Exhibit Location: The exhibit area is strategically located with respect to the main traffic flow of the conference activities.

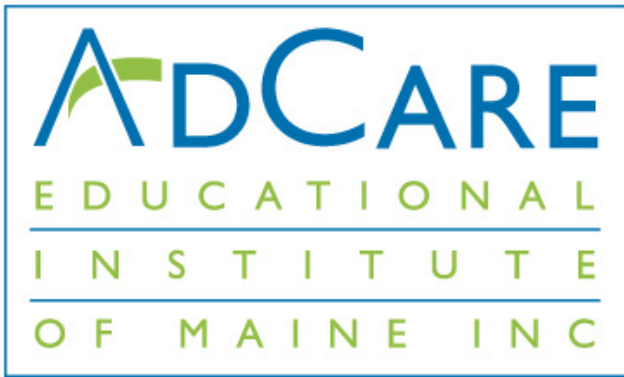
